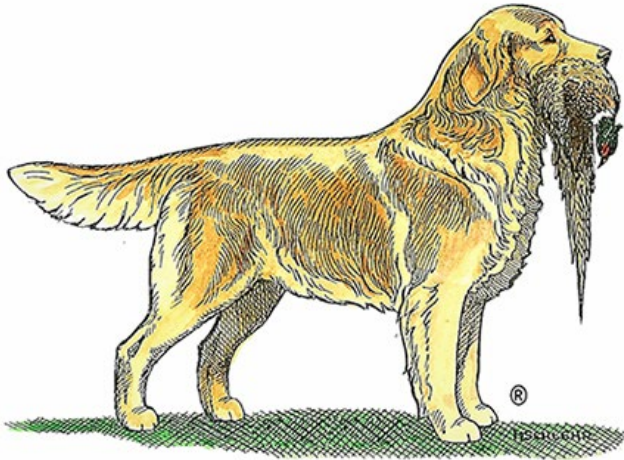

The tests will be held at the Flatlander Kennels 340057 County Road X Bayard, NE 69334. This event, like all National Specialty events, is only able to function because of the dedication of the judges, volunteers, and workers. There is no training on the grounds during this event.

Please park your vehicles in designated areas. Please be courteous to all dogs, exhibitors, and volunteers as well as other visitors. Please be respectful of the land.

Per GRCA regulations, handlers must submit a copy of each qualifying dog's AKC Registration to the Event Secretary on the day of the event. Recording and processing of the title will be withheld until the documentation is received.

Ducks and/or pheasants to be used in all stakes. The club may use mechanical devices ("wingers") for the WCX stakes if deemed necessary by the judges.
