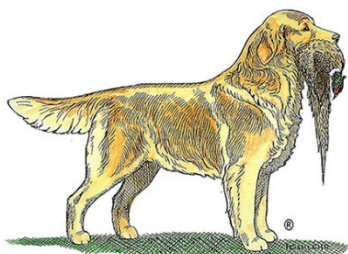

Welcome to the 2026 GRCA National Specialty Field Trial. This year's event is in Wellington, Colorado about 10 miles north of Ft Collins, CO. The trial will be held on three private properties. Thanks to Horsetooth Retriever Kennel and Kenny Trott and Marcy Wright, Wayne and Tracey Jensen and Ken and Esther McCartney. Please be respectful of these properties and follow all posted rules and instructions of the Marshall or Field Trial committee members.

PLEASE BE AWARE that there will also be a "Goldens Only" Hunt Test at this year's National and WC/WCX Tests following this field trial.

DRAWING The electronic draw will take place at 12:01 am Central Time on 27 August 2026 and will be posted online available for viewing upon final approval by the Golden Retriever Club of America.

REFUNDS For scratches BEFORE the close: Contact Entry Express at support@entryexpress.net or 1-800-863-3647. A scratch fee will be assessed by Entry Express for ANY scratch handled by Entry Express.

For scratches AFTER the close: In accordance with AKC rules, bitches in season, ill, injured or deceased dogs scratched after the close will be eligible for a FULL refund (less fees incurred by the Club i.e. Entry Express and AKC). To be eligible for refund, the Field Trial Secretary must be notified before the start of the stake the dog is entered in and for the case of ill or injured dogs, will require a note from a licensed veterinarian received by the Field Trial Secretary no later than ten (10) days after the completion of the event. NO EXCEPTIONS! Scratches for any other reason after the close or no shows will not receive a refund. No refunds will be provided on event grounds.
